Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

London Fraud Hub

If you are assigned to work in certain London Borough Councils that participate in the London Fraud Hub your data will be shared into the Hub in order to prevent and detect fraud. The Cabinet Office will be responsible for carrying out data matching exercises which allows potentially fraudulent claims and payments to be identified. Where a match is found, it indicates that there is an inconsistency and further investigation is required. No assumption can be made as to whether there is fraud, error or other explanation until an investigation is carried out.

The use of data by the cabinet Office in a data matching exercise is carried out with statutory authority under Part 6 of the Local Audit and Accountability Act 2014. It does not require the consent of the individuals concerned under the Data Protection Act 2018.

Data Matching by the Cabinet Office is subject to a **code of practice**.
